

## SINGAPORE ACADEMY OF LAW STAKEHOLDING SERVICE CIRCULAR 1/2020

On 3 April 2020, the Government announced stricter measures to further contain the spread of Covid-19 in Singapore. This 'circuit-breaker' will cover the period from 7 April 2020 to 4 May 2020. This circular addresses changes to the Stakeholding Service during this period.

With effect from 7 April 2020 to 4 May 2020 (inclusive), the operating hours of the SAL Stakeholding Service counter will be as follows:

Monday, Wednesday and Friday	2.30 p.m. to 4.30 p.m.
Tuesday and Thursday	Closed
Saturday, Sunday and Public Holiday	Closed

- The Stakeholding Forms issued via SAL Stakeholding Circular 1/2017 can be used for submissions to SAL. The forms can be downloaded from the SAL website<sup>1</sup>. Forms must now be submitted by email to <a href="mailto:stakeholding@sal.org.sg">stakeholding@sal.org.sg</a> and copied to the relevant solicitor from the other side; <a href="mailto:hardcopy submissions will not be accepted in this period.">hardcopy submissions will not be accepted in this period.</a> All duly signed forms must be submitted in PDF format bearing the relevant law firm stamps and accompanied by a cover letter on law firm letterhead. Forms received after 4.30pm will be treated as received on the following working day.
- 4 Purchasers' or vendors' solicitors who have previously submitted Form 6/Form 6A (Authorisation & Indemnity for Facsimile Instructions) can continue to fax the forms to SAL.
- 5 Purchasers' solicitors should advise their clients to submit the relevant deduction forms to SAL (and vendors' solicitors) early.
- The above limited operating hours and procedures may be extended beyond 4 May 2020 if the Government announces an extension of the Covid-19 'circuit-breaker' measures.
